4. DREDGING PERMIT, CLEAR LAKE, LAKE COUNTY; DEPARTMENT OF GEMERAL SERVICES, OFFICE OF ARCHITECTURE AND CONSTRUCTION - W.O. 6605, P.R.C. 3778.9.

After consideration of Calendar Item 22 attached, and upon motion duly made and carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT TO THE DEPARTMENT OF GENERAL SERVICES, OFFICE OF ARCHITECTURE AND CONSTRUCTION, TO DREDGE APPROXI-MATELY 165,000 CUBIC YARDS OF MATERIAL FROM THE FOLLOWING-DESCRIBED LAND:

A PARCEL OF SUBMERGED LAND IN CLEAR LAKE AND "OLD KELSEY CREEK" LYING WITHIN SECTION 36, T. 14 N., R. 9 W., M.D.M., MORE PARTI-CULARLY DESCRIBED AS FOLLOWS:

DEGINITING AT A POINT ON THE LOW WATER MARK OF CLEAR LAKE WHICH BEARS N. 17° 00' E., 3600 FEET MORE OR LESS FROM THE SOUTHWEST CORNER OF SAID SECTION 36; THENCE NORTH 1,050 FEET, S. 72° 00' E. 3,950 FEET, S. 03° 00' E. 1,750 FEET, AND WEST 300 FEET MORE OR LESS TO A POINT ON THE LOW WATER MARK OF CLEAR LAKE; THENCE NORTWERLY AND WESTERIX ALONG SAID LOW WATER MARK TO THE MOUTH OF CLD KELSEY CREEK; THENCE UP THE RIGHT BANK FOLLOWING THE LOW WATER LINE 2700 FEET MORE OR LESS TO THE END OF SAID OLD KELSEY CREEK; THENCE DOWN THE LEFT BANK ALONG THE LOW WATER MARK TO THE MOUTH OF SAID OLD KELSEY CREEK AT A POINT ON THE LOW WATER MARK OF CLEAR LAKE; THENCE WESTERLY ALONG THE LOW WATER MARK OF CLEAR LAKE TO THE POINT OF BEGINNING; CONTAINING 87 ACRES MORE OR LESS.

THE CONSIDERATION FOR THE ISSUANCE OF THE PERMIT IS THE PUBLIC BENEFIT.

APPLICATION FOR DREDGING PERMIT, SUBMERGED LANDS, CLEAR LAKE, LAKE COUNTY; DEPARTMENT OF GENERAL SERVICES, OFFICE OF ARCHITECTURE AND CONSTRUCTION -W.O. 6605.

On October 17, 1966, the Commission issued to the Department of General Services, Office of Architecture and Construction, Dredging Permit P.R.C. 3605.9 to dredge 190,000 cubic yards of material from State lands in Clear Lake and to place it upon adjacent State park land, effective from September 26, 1966, to December 31, 1966, for the purpose of shoreline development of the adjacent State park land. Of the 190,000 cubic yards approved for removal, less than 25,000 were actually removed before the permit expired, and the Department has now applied for issuance of a new permit to dredge the remaining 165,000 cubic yards of material.

The applicant has been informed by the Department of the Army that a federal permit is not required since no navigational problems are involved.

The project has the approval of the Department of Parks and Recreation. The Department of Fish and Game has also approved the project, but has requested that the following conditions be included in the permit:

A 4 S 1 1. All dredged material will by land-disposed as stated in the application.

2. Dredging operations will be conducted in a manner to conform with water quality standards as established by the Water Quality Conford Board.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A FERMIT TO THE DEPARTMENT OF GENERAL SERVICES, OFFICE OF ARCHITEC-TURE AND CONSTRUCTION, TO DREDGE APPROXIMATELY 165,000 CUBIC YARDS OF MATERIAL FROM THE FOLLOWING-DESCRIBED LAND;

A PARCEL OF SUEMERGED LAND IN CLEAR LAKE AND "OLD KELSEY CREEK" LYING WITHIN SECTION 36, T. 14 N., R. 9 W., M.D.M., MORE PARTI-CULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE LOW WATER MARK OF CLEAR LAKE WHICH BEARS N. 17° 00' E., 3600 FEET MORE OR LESS FROM THE SOUTHWEST CORNER OF SAID SECTION 36; THENCE NORTH 1,050 FEET, S. 72° 00' E. 3,950 FEET, S. 03° 00' E. 1,750 FEET, AND WEST 300 FEET MORE OR LESS TO A POINT ON THE LOW WATER MARK OF CLEAR LAKE; THENCE NORTHERLY AND WESTERLY ALONG SAID LOW WATER MARK TO THE MOUTH OF OLD KELSEY CREEK; THENCE UP THE RIGHT BANK FOLLOWING THE LOW WATER LINE 2700 FEET MORE OR LESS TO THE END OF SAID OLD KELSEY CREEK; THENCE DOWN THE LEFT BANK ALONG THE LOW WATER MARK TO THE MOUTH OF SAID OLD KEISEY CREEK AT A FOINT ON THE LOW WATER MARK OF CLEAR LAKE; THENCE WESTERLY ALONG THE LOW WATER MARK OF CLEAR LAKE TO THE POINT OF BEGINNING; CONTAINING 87 ACRES MORE OR LESS.
