APPLICATION FOR GEOLOGICAL SURVEY PERMIT; DEL NORTE, HUMBOLDT, MENDOCINO, SONOMA, MARIN, SAN FRANCISCO, SAN MATEO, SANTA CRUZ, MONTEREY, SAN LUIS OBISPO, SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE, AND SAN DIEGO COUNTIES; PHILLIPS PETROLEUM COMPANY - W.O. 6635.

An application has been received from Phillips Petroleum Company for a permit to conduct geological survey operations in the California offshore area lying between the northern and the southern boundary of the State of California.

Phillips Petroleum Company has been conducting core-drilling operations under Geological Survey Permit P.R.C. 3484.1, covering the tide and submerged lands under the jurisdiction of the State Lands Commission in the area lying between a line drawn due West from Point Arguello, Santa Barbara County, and the southern boundary of the State of California.
