21. GEOLOGICAL SURVEY PERMIT; DEL NORTE SOUTH THROUGH SAN DIEGO COUNTY; STANDARD OIL COMPANY OF CALIFORNIA, WESTERN OPERATIONS, INC. - W.O. 6658, P.R.C. 3805.1.

After consideration of Calendar Item 26 attached, and upon motion duly made and carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO STANDARD OIL COMPANY OF CALIFORNIA, WESTERN OPERATIONS, INC., A GEOLOGICAL SURVEY PERMIT CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOLOGICAL SURVEY OPERATIONS, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN THE NORTHERN BOUNDARY AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.

THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM JULY 27, 1967, THROUGH JAMUARY 26, 1968, AND IS TO SUPERSEDE GEOLOGICAL SURVEY PERMITS P.R.C.s 2828.1, 2930.1, AND 3115.1.

THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ANY INSPECTION COSTS.

APPLICATION FOR GEOLOGICAL SURVEY PERMIT; DEL NORTE, HUMBOLDT, MENDOCINO, JONOMA, MARIN, SAN FRANCISCO, SAN MATED, SANTA CRUZ, MONTEREY, SAN LUIS OBISPO, SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE, AND SAN DIEGO COUNTIES; STANDARD OIL COMPANY OF CALIFORNIA, WESTERN OPERATIONS, INC. - W.O. 6658.

An application has been received from Standard Oil Company of California, Western Operations, Inc., for a permit to conduct geological survey operations in California offshore waters from the northern to the southern boundary of the State of California. Standard Oil Company of California has been conducting core-drilling operations in State waters under three geological permits, P.R.C. 2828.1, P.R.C. 2930.1, and P.R.C. 3115.1, covering part of the offshore area included in the new application. These permits expire on August 15, 1967. The statutory filing fee has been paid by the applicant.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO STANDARD OIL COMPANY OF CALIFORNIA, WESTERN OPERATIONS, INC., A GEOLOGICAL SURVEY PERMIT CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOLOGICAL SURVEY OPERATIONS, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN THE NORTHERN BOUNDARY AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.

THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM JULY 27, 1967, THROUGH JANUARY 26, 1968, AND IS TO SUPERSED. GEOLOGICAL SURVEY PERMITS P.R.C.S 2828.1, 2930.1, AND 3115.1.

THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ANY INSPECTION COSTS.
