APPROVAL OF MODIFIED EXHIBITS C AND D, 1967 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, WILMINGTON OIL FIELD - W.O. 5200.301 AND W.O. 5200.317.

The City of Long Beach and the State, pursuant to the provisions of Section 5(g), Ch. 138/64, 1st E.S., have mutually agreed to modified Exhibits C and D, setting forth range of rates of production, and range of rates and pressures of injection, respectively, expected during the third quarter of 1967 under the 1967 Plan of Development and Operations and Budget for the Long Beach Unit.

When the 1967 Plan of Development and Operations and Budget was approved by the Commission, at its meeting of October 27, 1966, it was anticipated that modifications in the range of rates and pressures, as set forth in Exhibits C and D, would be made quarterly pursuant to the provisions of Section 5(g) of Chapter 138.

Revised production and injection rates and pressures for the third quarter of 1967 have now been established, reviewed, and approved by the Commission's staff, and have been set forth in modified Exhibits C and D. The Executive Officer, by letter dated July 10, 1967, approved the modified Exhibits C and D for the third quarter of 1967, subject to ratification by the Commission.

IT IS RECOMMENDED THAT THE COMMISSION RATIFY THE ACTION OF THE EXECUTIVE OFFICER, PURSUANT TO SECTION 5(g), CH. 138/64, 1st E.S., APPROVING:
