ASSIGNMENT OF MINERAL EXTRACTION LEASE P.R.C. 2616.1, MONTEREY COUNTY; SEASIDE SAND AND GRAVEL COMPANY, INC. - W.O. 5437.

Mineral Extraction Lease P.R.C. 2616.1, covering approximately one acre of tide and submerged lands in the vicinity of Marina, Monterey County, was issued on July 28, 1960, pursuant to competitive bidding, to Seaside Sand and Gravel Company, Inc., for a term of 20 years. The lessee is the owner of the adjoining upland.

An application has been submitted by Mr. Floyd Bradley, the President of Seaside Sand and Gravel Company, Inc., requesting approval of an assignment of the lease to Floyd Bradley and Associates.

The bond obligations required by the lease have been met by the assignee, and a form of assignment has been executed by Seaside Sand and Gravel Company, Inc., assignor, and by Mr. Floyd Bradley of Floyd Bradley and Associates.

The statutory filing fee and all royalties due have been paid. Advance rentals in the amount of \$2 are still payable.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE APTROVAL OF THE ASSIGNMENT OF LEASE P.R.C. 2616.1 FROM SEASIDE SAND AND GRAVEL COMPANY, INC., TO FLOYD BRADLEY AND ASSOCIATES, WITH THE ASSIGNEE TO BE BOUND BY THE TERMS OF THE LEASE TO THE SAME EXTENT AS THE ORICINAL LESSEE.
