An application has been received from Charles Cox and Blanche C. Cox for the purchase of minerals reserved by the State of California in the sale by and through the Controller of the State of California, in deed dated February 7, 1947, and recorded February 20, 1947, in Volume 1029 of Official Records, at page 312, San Joaquin Records. The Commission is authorized to dispose of minerals reserved in the sale of escheated lands by Fublic Resources Code Sections 6403 and 6406 (Ch. 1212, Stats. of 1949).

The subject land consists of portions of two lots, the two portions being contiguous and together, 382 feet wide and 342 feet long. From a review of geologic reports and mineralogical literature and the apparent absence of mineral operations in this general area, it is the conclusion of the Division that while a mineral potential may exist below 200 feet of the surface, above 200 feet the land may be classified as not having any currently known mineral value. The \$5 filing fee and \$10 payment have been received from the applicant.
