OTHER PERTINENT INFORMATION:

Life-of-structure Permit P.R.C. 1560.9 was issued to the Port Hueneme Sanitary District for 49 years on October 14, 1955. The permit provided an easement for a sewer outfall, and for a pier that was used for construction but converted to recreational use upon completion of construction of the outfall. On November 21, 1963, the Commission approved an amendment for a 4000-foot extension to the sever line.

On September 25, 1967, the Commission approved an amendment request by the City of Port Hueneme for a 950-foot extension to the pier (Minute Item 4, page 911). 50% of the cost, or approximately \$150,000, will be borne by the Wildlife Conservation Board. It was determined subsequently that the Port Hueneme Sanitary District had conveyed the existing pier improvement to the City of Port Hueneme. In order to define the two uses as between the City of Port Hueneme and the Port Hueneme Sanitary District, it was proposed to issue to the City a new permit which will include the existing pier and the extension, while permit P.R.C. 1560.9 will remain in effect with the Sanitary District as to the sever outfall.
