5. AUTHORIZATION TO EXTRACT MATERIAL FROM THE BED OF THE SACRAMENTO RIVER, SACRAMENTO AND YOLO COUNTIES; DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS - W.O. 6705, P.R.C. 3862.9.

After consideration of Calendar Item 38 ettached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE APPROVAL, IN ACCORDANCE WITH THE PROVISIONS OF SECTION 101.5 OF THE STREETS AND HIGHWAYS CODE, OF THE MAPS SUBMITTED BY THE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, DESCRIBING THE AREA OF SOVUREIGN LANDS IN THE BED OF THE SACRAMENTO RIVER, SACRAMENTO AND YOLO COUNTIES, FROM WHICH IT IS PROPOSED TO EXTRACT APPROXIMATELY 125,000 CUBIC YARDS OF MAPERIAL IN CONNECTION WITH THE PROPOSED HIGHWAY 880 CONSTRUCTION, SUBJECT TO THE CONDITION THAT OPERATIONS SHALL BE IN ACCORDANCE WITH THE CONDITIONS SPECIFIED BY THE DEPARTMENT OF FISH AND GAME, AND SNALL CONFORM TO CONDITIONS SPECIFIED BY THE DEPARTMENT OF WATER RESOURCES IN THE LETTER TO THE RECLAMATION BOARD DATED NOVEMBER 7, 1967.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE APPROVAL, IN ACCORDANCE WITH THE PROVISIONS OF SECTION 101.5 OF THE STREETS AND HIGHWAYS CODE, OF THE MAPS SUBMITTED BY THE DEPARIMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, DESCRIBING THE AREA OF SOVEREIGN LANDS IN THE BED OF THE SACRAMENTO RIVER, SACRAMENTO AND YOLO COUNTIES, FROM WHICH IT IS PROPOSED TO EXTRACT APPROXI-MATELY 125,000 CUBIC YARDS OF MATERIAL IN CONNECTION WITH THE PROPOSED HIGHWAY 880 CONSTRUCTION, SUBJECT TO THE CONDITION THAT OPERATIONS SHALL BE IN ACCORD-ANCE WITH THE CONDITIONS SPECIFIED BY THE DEPARTMENT OF FISH AND GAME, AND SHALL CONFORM TO CONDITIONS SPECIFIED BY THE DEPARTMENT OF WATER RESOURCES IN THE LETTER TO THE RECLAMATION BOARD DATED NOVEMBER 7, 1967.
