18. EXTENSION OF TERM, DREDGING PERMIT P.R.C. 3355.1, SUNSET HARBOUR, ORANGE COUNTY; DECON CORPORATION - W.O. 6882.

After consideration of Calendar Item 16 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION APPROVES THE EXTENSION THROUGH DECEMBER 31, 1968, OF DREDGING PERMIT P.R.C. 3355.1, ISSUED TO THE DECON CORPORATION, TO DREDGE APPROXIMATELY 40,000 CUBIC YARDS OF MATERIAL, AT A ROYALTY RATE OF \$.05 PER CUBIC YARD FOR ALL MATERIAL REMOVED, FROM AN AREA OF STATE-OWNED TIDE AND SUBMERGED LANDS IN SUNSET HARBOUR, ORANGE COUNTY. ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN IN FULL FORCE AND EFFECT.

EXTENSION OF DREDGING PERMIT

PERMIT: P.R.C. 3355.1 (approved August 26, 1965, Minute Item 17, page 11,599)

PERMITTEE: Decon Corporation

LOCATION: Tide and submerged lands, Sunset Harbour, Orange County

ORIGINAL AMOUNT TO BE  
DREDGED AND DISPOSITION:

Approximately 40,000 cubic yards of material to be dredged, at a royalty rate of \$0.05 per cubic yard for all material extracted. 20,000 cubic yards will be used for filling adjacent property owned by Decon Corporation; the remaining 20,000 cubic yards which is unsuitable, consisting of half trash and half sandy silt, is to be hauled off by truck and deposited in a dump area on the upland.

REASON FOR EXTENSION:

5000 cubic yards remain to be dredged. A 12" dredge will arrive in Sunset Beach about January 12, 1968, to be assembled and ready for work in approximately seven to ten days.

OTHER PERTINENT INFORMATION:

- a. All State agencies have approved project.
- b. U.S. Corps of Engineers has approved project.
- c. From original amount, 5000 cubic yards remain to be dredged.
