4. PUBLIC AGENCY PERMIT (RIGHT-OF-WAY), SUBMERGED LAND, AMERICAN RIVER, SACRAMENTO COUNTY, COUNTY OF SACRAMENTO - W.O. N-0079, P.R.C. 3948.9.

After consideration of Calendar Item 4 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

PUBLIC AGENCY PERMIT (RIGHT-OF-WAY)

APPLICANT: County of Sacramento

LOCATION: A 0.169-acre strip of land across the American River, Sacramento County

PROPOSED USE: The construction of a sanitary sewer pipe line

TERM: 49 years, from April 1, 1968

CONSIDERATION: No charge (the public health)

Lessee: County of Sacramento

A strip of submerged land in the American River, Sacramento County, California, 10 feet in width, the centerline of which is described as follows:

BEGINNING at a point on the left or northerly bank of the American River from which a one and one-quarter inch iron pipe monument tagged "L.S. 2651" marking the southwest corner of that certain 307.62 acre tract of land designated "Haggin Bottom Land Company, 307.62 Acres" shown on the Record of Survey entitled "Haggin Bottom Land Company Located in Rancho Del Paso" recorded in the office of the Recorder of Sacramento County in Book 4 of Surveys, Map No. 24, having coordinates X = 2,188,775.182 Y = 333,851.047 bears North 66° 22' 06" West 1,397.84 feet; thence South 3° 52' 59" East 222.18 feet to a point in the American River on the southwesterly boundary of said 307.62 acre tract; thence continuing South 3° 52' 59" East 207.82 feet more or less to a point on the right, or southerly bank of the American River, containing 0.169 acre.

The bearings and distances used in the above description are based on the California Coordinate System, Zone 2.

EXCEPTING any portion of the above described land lying above the ordinary low water mark.
