46. AWARD OF OIL AND GAS LEASE, TIDE AND SUBMERGED LAND, SOLANO AND SACRAMENTO COUNTIES; SIGNAL OIL AND GAS COMPANY - W.O. 6830, P.R.C. 3962.1.

After consideration of Calendar Item 47 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION ACCEPTS THE BID MADE BY AND AUTHORIZES THE ISSUANCE OF AN OIL AND GAS LEASE TO SIGNAL OIL AND GAS COMPANY FOR APPROXIMATELY 140 ACRES OF TIDE AND SUBMERGED LANDS DESIGNATED AS W.O. 6830 IN SOLANO AND SACRAMENTO COUNTIES, AS DETAILED IN THE NOTICE OF INTENTION PUBLISHED FEBRUARY 6 AND 13, 1968.
