5. PUBLIC AGENCY PERMIT (RIGHT-OF-WAY), SOVEREIGN LAND, AMERICAN RIVER, SACRAMENTO COUNTY; SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.O. N-0133, P.R.C. 3957.9.

After consideration of Calendar Item 42 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO SACRAMENTO MUNICIPAL UTILITY DISTRICT OF A 49-YEAR PUBLIC AGENCY PERMIT (RIGHT-OF-WAY) FROM JUNE 1, 1968, PURSUANT TO SECTION 12808 OF THE PUBLIC UTILITIES CODE, FOR INSTALLATION OF A CONDUIT TO TRANSMIT ELECTRICITY OVER THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

PUBLIC AGENCY PERMIT (RIGHT OF WAY)

APPLICANT: Sacramento Municipal Utility District

LOCATION: Sovereign land within a 5-x 250-foot strip across the American River at the Watt Avenue Bridge, Sacramento County

PROPOSED USE: The attachment of a conduit for transmission of electricity to the existing bridge

TERM: 49 years, from June 1, 1968

CONSIDERATION: No charge, pursuant to Section 12808 of the Public Utilities Code

PREREQUISITE ITEMS: Applicant is lessee or permittee of upland. The County of Sacramento has issued its permit for attachment of the conduit to the bridge.

EXHIBIT "A"

A portion of Section 60, as said section is shown on the official "Map of Survey and Subdivision of Rancho Del Paso" recorded in the office of the Recorder of Sacramento County on March 4, 1911, in Book A of Surveys, Map No. 94; and a portion of Section 12, Township 8 North, Range 5 East, M.D.M.

Within a strip of land of the uniform width of 5 feet the center line of which is described as follows:

BEGINNING at a point on the right or northerly bank of the American River, from which point the southeast corner of that certain subdivision entitled "Sierra Oaks Unit No. 10", recorded in said Recorder's office on August 3, 1961, in Book 66 of Maps, Map No. 21; bears the following two courses:

- 1) N 04° 03' 40" W 244.0 feet
- 2) N 69° 48' 40" W 229.04 feet; thence from said point of beginning S 04° 03' 40" E 250.0 feet to a point on the left or southerly bank of the American River, the center line of said strip being coincident with the East edge of the Watt Avenue bridge across the American River.

The meridian of this description is the same as that of the above-described Sierra Oaks Unit No. 10.

EXCEPTING THEREFROM that portion lying above the natural low water line.
