

29. GEOLOGICAL SURVEY PERMIT, DEL NORTE COUNTY SOUTH THROUGH SAN DIEGO COUNTY; TEXACO INC. - W.O. 7017, P.R.C. 3983.1.

After consideration of Calendar Item 4 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO TEXACO INC. OF A GEOLOGICAL SURVEY PERMIT FROM JUNE 19, 1968, THROUGH DECEMBER 18, 1968, ON TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION LYING BETWEEN THE NORTHERN BOUNDARY AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA. THIS PERMIT IS TO SUPERSEDE GEOLOGICAL SURVEY PERMITS P.R.C. 2764.1 AND P.R.C. 2872.1.

APPLICATION FOR GEOLOGICAL SURVEY PERMIT

APPLICANT: Texaco Inc.

LOCATION: The offshore area lying between the northern and the southern boundary of the State of California

METHOD OF EXPLORATION: Core-hole drilling

TERM: From June 19, 1968, through December 18, 1968

FILING FEE: \$5 submitted

EXPENSES: To be reimbursed by the permittee

OPERATING CONDITIONS: Established by the Commission

OTHER PERTINENT INFORMATION:

Texaco Inc. has been conducting core-drilling operations in State waters under two geological permits, P.R.C. 2764.1 expiring July 27, 1968, and P.R.C. 2872.1 expiring September 30, 1968, and is now requesting that these two permits be combined into one permit.
