

31. GEOPHYSICAL EXPLORATION PERMIT, MENDOCINO COUNTY SOUTH THROUGH SAN DIEGO COUNTY; ATLANTIC RICHFIELD COMPANY - W.O. 7028, P.R.C. 3985.1.

After consideration of Calendar Item 7 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO ATLANTIC RICHFIELD COMPANY OF A GEOPHYSICAL EXPLORATION PERMIT FROM JUNE 19, 1968, THROUGH DECEMBER 18, 1968, ON TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION LYING BETWEEN THE SEAWARD EXTENSION OF THE NORTHERN BOUNDARY OF MENDOCINO COUNTY AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA EXCEPTING THE FOLLOWING-DESCRIBED AREAS:

1. SAN FRANCISCO BAY AND OTHER INLAND WATERS DRAINING THEREIN;
2. LANDS INCLUDED IN SECTION 6871.2(b) OF THE PUBLIC RESOURCES CODE;
3. LANDS LYING ADJACENT TO THE MAINLAND BETWEEN A LINE FORMING THE NORTHWESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY, AND THE SEAWARD EXTENSION THEREOF, AND A LINE FORMING THE SOUTH-EASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF.

THIS PERMIT IS TO SUPERSEDE GEOPHYSICAL EXPLORATION PERMITS P.R.C. 2765.1, AND P.R.C. 3055.1.

Atlantic Richfield Company has been conducting seismic operations in State waters under two geophysical permits, P.R.C. 2765.1 expiring July 31, 1968, and P.R.C. 3035.1 expiring July 24, 1968, and is now requesting that these two permits be combined into one permit.
