

38. OIL AND GAS LEASE OFFER, PUBLICATION OF NOTICE OF CONSIDERATION, TIDE AND SUBMERGED LAND, CONTRA COSTA AND SAN JOAQUIN COUNTIES - W.O. 6941.

After consideration of Calendar Item 48 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE PUBLICATION OF A NOTICE, AS REQUIRED BY SECTION 6873.2 OF THE PUBLIC RESOURCES CODE, THAT THE COMMISSION INTENDS TO CONSIDER OFFERING A LEASE FOR THE EXTRACTION OF OIL AND GAS FROM AN AREA OF TIDE AND SUBMERGED LANDS DESCRIBED AS FOLLOWS:

THOSE TIDE AND SUBMERGED LANDS OWNED BY THE STATE LYING SOUTHERLY OF STATE GAS LEASE EASEMENT NO. 415, IN PROJECTED SECTION 31, T. 3 N., R. 4 E., PROJECTED SECTIONS 6, 7, 8, 17, 18, 19 AND 20, T. 2 N., R. 4 E., AND PROJECTED SECTIONS 1, 12 AND 13, T. 2 N., R. 3 E., M.D.B. & M., IN THE COUNTIES OF CONTRA COSTA AND SAN JOAQUIN, STATE OF CALIFORNIA, CONTAINING 550 ACRES MORE OR LESS.
