

8. RESERVATION OF LANDS FOR HIGHWAY PURPOSES, SOVEREIGN LAND, EEL RIVER, HUMBOLDT COUNTY; STATE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS - W.O. N-0160, P.R.C. 3992.9.

After consideration of Calendar Item 18 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE EXECUTION OF AN AGREEMENT WITH THE STATE DIVISION OF HIGHWAYS, PURSUANT TO SECTION 101.5 OF THE STREETS & HIGHWAYS CODE, FOR THE RESERVATION OF UNGRANTED SOVEREIGN LAND FOR HIGHWAY PURPOSES ACROSS THE EEL RIVER, HUMBOLDT COUNTY, LOCATED IN T. 2 N., R. 1 E., AND R. 1 W., H.B.M., AS SHOWN ON HIGHWAYS MAP 01-HUM-101-P.M.
