40. EXTENSION OF TERM, GEOPHYSICAL EXPLORATION PERMIT P.R.C. 3923.1; SOLANO COUNTY; STANDARD OIL COMPANY OF CALIFORNIA, WESTERN OPERATIONS, INC.

After consideration of Calendar Item 6 attached, and upon motion duly made and carried, the following resolution was adopted:

At the request of the Wildlife Conservation Branch of the Department of Fish and Game, exploration work on Joyce, Grizzly, and Hammond Islands is to be restricted to the period February 1 to September 1, 1969, or to any other modified period imposed by the Department of Fish and Game.
