b. AMENDMENT OF PERMIT P.R.C. 2881.9, PIERPONT BAY, VENTURA COUNTY; VENTURA PORT DISTRICT - W.O. 7103.

AMENDMENT OF PERMIT P.R.C. 2881.9

APPLICANT: Ventura Port District

LOCATION: Pierpont Bay, Ventura County

PROPOSED USE: To realign the existing permit area for the inclusion and construction of a detached breakwater and the establishment of new boundaries for dredging areas

TERMS: Initial period: 49 years, from May 11, 1962

CONSIDERATION: The public use and benefit  
The public safety

PREREQUISITE ITEMS: U.S.A. Corps of Engineers navigational permit issued  
Applicant is owner of upland

EXHIBIT "A"

A parcel of tide and submerged lands adjacent to and easterly of that certain parcel as described in the permit to the Ventura Port District per California State Lands Commission, P.R.C. 2881.9 and being 5000 feet northerly from the mouth of the Santa Clara River, further described as follows:

Beginning at a point in the Santa Barbara Channel which bears N. 55° 36' 28" W. 2,753.08 feet from U. S. Coast and Geodetic Triangulation Station "SANDY 3" (Zone 5 California Coordinates X = 1,617,932.34 feet and Y = 272,914.09 feet); thence from said point of beginning N. 32° 59' 58" E. 1,696.27 feet along the northwesterly line of said permit to the Ventura Port District, thence S. 85° 00' 00" W. 1,416.08 feet; thence S. 10° 00' 00" E. 1,965.11 feet to the northerly line of a permit to Union Oil Company per California State Lands Commission, P.R.C. 602.1, thence along the northeasterly line of said permit to Union Oil Company S. 71° 23' 50" E. 510.88 feet to the southwesterly corner of said permit per P.R.C. 2881.9; thence N. 22° 57' 50" E. 867.80 feet to the point of beginning, containing 31.11 acres more or less.
