

7. INDUSTRIAL LEASE (RIGHT-OF-WAY), BELMONT SLOUGH, SAN MATEO COUNTY; ABC MARINE WORLD, INC. - W.O. 7022, P.R.C. 4035.1.

After consideration of Calendar Item 2 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO ABC MARINE WORLD, INC. OF A 49-YEAR RIGHT-OF-WAY, FROM SEPTEMBER 26, 1968, IN CONSIDERATION OF ANNUAL RENTAL IN THE AMOUNT OF \$20 DURING THE FIRST FIVE YEARS, WITH THE STATE RESERVING THE RIGHT TO REVIEW AND RESET A REASONABLE RENTAL ON EACH FIFTH ANNIVERSARY, FOR INSTALLATION OF A 12-INCH TRANSITE SALT-WATER INTAKE PIPE ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

INDUSTRIAL LEASE (RIGHT-OF-WAY)

APPLICANT: ABC Marine World, Inc.
LOCATION: A right-of-way 5 feet in width, crossing Belmont Slough,
San Mateo County
PROPOSED USE: Installation of a 12-inch transite intake pipe 130 feet long
for salt-water intake
TERMS: Initial period: 49 years, from September 26, 1968
CONSIDERATION: \$20 per annum

BASIS FOR CONSIDERATION:

Size of the installation qualifies for the minimum charge,
which is \$20 per year

Subject to approval by the Corps of Engineers.
Applicant is owner of upland.
