LOCATION: A 59.62-acre parcel atop Mount Diablo, Contra Costa County

PRESENT USE: The operation of a communications center

CHARACTER OF SUBLEASES:

The operation of five mobile repeaters and one base station,
as listed in recommendation hereinafter

TERMS OF BASIC LEASE:

Initial period: 15 years, from March 16, 1959
Renewal options: 2 additional periods of 10 years each
Surety bond: \$5000

CONSIDERATION (1) Basic lease: \$1,098 per annum
TO STATE: (2) Subleases: None

OTHER PERTINENT INFORMATION:

The Department of General Services, Communications Division, has conducted compatibility tests of the equipment as installed by subleases. The subleases were found acceptable from a technical standpoint. Additionally, the State Department of General Services has filed a purchase application on behalf of the Division of Beaches and Parks to acquire title from the Commission to the 59.62 acres embraced in master Lease P.R.C. 2364.2. Any sale would be made subject to said lease, as well as to any and all subleases which previously may have been approved by the Commission.
