

25. GEOPHYSICAL SURVEY PERMIT, OFFSHORE AREA LYING BETWEEN MENDOCINO AND SAN DIEGO COUNTIES; EXPLORATION SERVICES CO. - W.O. 7095, P.R.C. 4107.1.

UPON MOTION DULY MADE AND CARRIED, THE COMMISSION AUTHORIZED THE FOLLOWING:

ISSUANCE TO EXPLORATION SERVICES CO. OF A GEOPHYSICAL SURVEY PERMIT, FOR THE PERIOD NOVEMBER 21, 1968, THROUGH MAY 20, 1969, ON TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION LYING BETWEEN THE SEAWARD EXTENSION OF THE NORTHERN BOUNDARY OF MENDOCINO COUNTY AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA, EXCEPTING THE FOLLOWING-DESCRIBED AREAS:

1. SAN FRANCISCO BAY AND OTHER INLAND WATERS DRAINING THEREIN;
2. LANDS INCLUDED IN SECTION 6871.2(b) OF THE PUBLIC RESOURCES CODE;
3. LANDS LYING ADJACENT TO THE MAINLAND BETWEEN A LINE FORMING THE NORTH-WESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY, AND THE SEAWARD EXTENSION THEREOF, AND A LINE FORMING THE SOUTHEASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF.
4. LANDS IN MONTEREY BAY.

APPLICATION FOR GEOPHYSICAL SURVEY PERMIT

APPLICANT: Exploration Services Co.

LOCATION: The offshore area lying between the seaward extension of the northern boundary of Mendocino County and the southern boundary of the State of California

METHOD OF EXPLORATION: Seismic

TERM: From November 21, 1968, through May 20, 1969

FILING FEE: \$5 submitted

EXPENSES: Inspection costs to be reimbursed by the permittee

PREREQUISITE ITEMS: a. Fish and Game Commission's permit
b. Certificate of Incorporation in the State of California

OPERATING CONDITIONS: Established by the State Lands Commission

NOTIFICATION: The Boards of Supervisors of the affected counties, the Greater Santa Cruz Chamber of Commerce, and the Mayor of the City of Santa Barbara

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE ISSUANCE TO EXPLORATION SERVICES CO. OF A GEOPHYSICAL SURVEY PERMIT, FOR THE PERIOD NOVEMBER 21, 1968, THROUGH MAY 20, 1969, ON TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION LYING BETWEEN THE SEAWARD EXTENSION OF THE NORTHERN BOUNDARY OF MENDOCINO COUNTY AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA, EXCEPTING THE FOLLOWING-DESCRIBED AREAS:
