

5. 49-YEAR PUBLIC AGENCY PERMIT, SUBMERGED LAND IN COYOTE HILLS SLOUGH, ALAMEDA COUNTY, FOR MAINTENANCE OF FLOOD-CONTROL CHANNEL; ALAMEDA COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT - W.O. 5525, P.R.C. 4110.9.

PUBLIC AGENCY PERMIT

APPLICANT: Alameda County Flood Control and Water Conservation District

LOCATION: Three noncontiguous parcels of State submerged land in Coyote Hills Slough within the Alameda County Flood Control Channel
