

18. DREDGING PERMIT, HUMBOLDT BAY AT CITY OF EUREKA, HUMBOLDT COUNTY, FOR LADEN-VESSEL CLEARANCE; EUREKA FOREST PRODUCTS, INC. - W.O. 7118, P.R.C. 4133.1.

After consideration of Calendar Item 35 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO EUREKA FOREST PRODUCTS, INC., OF A PERMIT, EFFECTIVE DECEMBER 19, 1968, THROUGH DECEMBER 31, 1969, TO DREDGE APPROXIMATELY 8,400 CUBIC YARDS OF MATERIAL FROM STATE LANDS IN HUMBOLDT BAY, HUMBOLDT COUNTY, WITH ROYALTY PAYMENT OF \$0.05 PER CUBIC YARD FOR ALL MATERIAL DREDGED, SUCH LANDS BEING DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

## APPLICATION FOR DREDGING PERMIT

APPLICANT: Eureka Forest Products, Inc.

DREDGE LOCATION: Humboldt Bay at City of Eureka, Humboldt County

TYPE OF LAND: Tide and submerged

PURPOSE: For laden-vessel clearance

AMOUNT TO BE DREDGED: Approximately 8,400 cubic yards

## DISPOSITION OF DREDGED MATERIAL:

Site No. 1 - Applicant's property near dredge site

Site No. 2 - Other private property in City of Eureka

CONSIDERATION: \$0.05 per cubic yard royalty for material removed

## OTHER PERTINENT INFORMATION:

1. Dredging is for improvement of applicant's shiploading operations
2. Spoils will be used for private-property improvement
3. Corps of Engineers has issued a letter of permission for the project
4. The State Department of Parks and Recreation has made an examination of the proposed project, pursuant to Section 6818 of the Public Resources Code, and has no objections
5. The other State agencies concerned have commented on the project as follows:
  - a. The Department of Fish and Game recommends that reasonable care be exercised to prevent the entrance of spoil material into the waters of Humboldt Bay
  - b. The Department of Water Resources has no objections
  - c. The Water Quality Control Board requests that the requirements of their "Water Quality Control Policy for Humboldt Bay" be met

Survey No. 72, East side of Humboldt Bay, City of Eureka, County of
