## PUBLIC AGENCY PERMIT

APPLICANT: Central Contra Costa Sanitary District

LCCATION: Two parcels (0.175 and 0.054 acre) of sovereign land in Carquinez Strait at Martinez, Contra Costa County

PROPOSED USE: The installation of piping to form part of the City sever system

TERM: 45 years, from October 25, 1968

CONSIDERATION: No charge (the public health and benefit)

PREREQUISITE ITEM:

U. S. Army Corps of Engineers permit issued

STATUTORY AND OTHER REFERENCES:

- The sovereign land covered by the proposed permit is now under permit to the City of Martinez for a term that coincides with that recommended herein. The District is taking over the City's sever system.
- 2. The annual rental value of the two parcels is \$108.68.
- 3. A nonmonetary consideration is justified for this permit on the basis of a policy that in general free easements across State lands for sewage disposal contribute to Statewide protection of the public health.
