RESCISSION OF AUTHORIZATION TO GRANT DRILLING DEFERMENT AND QUITCLAIM OF OIL AND GAS LEASE P.R.C. 3685.1

LESSEE: McCulloch Oil Corporation of California

LOCATION: South Bay Aqueduct, Alameda County

ACREAGE: 64.71 acres

REASON FOR QUITCLAIM: Based on current geological evaluation of the Livermore prospect, which is supported by dry holes drilled around the perimeter of the producing area, the productive limits of the field appear to be confined to the present productive area. As a result, McCulloch is surrendering the lands believed to be outside the producing area.

PREREQUISITE ITEMS: a. Quitclaim submitted by Lessee, dated December 3, 1968

b. Compliance with terms and conditions of the lease through December 3, 1968

OTHER PERTINENT INFORMATION:

On September 13, 1968, McCulloch Oil Corporation _quested a deferment of lease-drilling requirements. On November 21, 1968 (Minute Item 34, page 1,384), the Commission authorized the granting of a deferment of drilling requirements through June 13, 1969. Since that time McCulloch has drilled and abandoned a dry hole near the northwest portion of the lease.
