On October 2h, 1968 (Minute Item 37, page 1268), the State Lands Commission approved the sale by the City of Long Beach to the Refevelopment Agency of the City of Long Beach of certain portions of Lots 24 through 38 inclusive of the Ocean Park addition, and of Lots 3 through 10 inclusive in Block 2 of the Seaside Plat No. 3, for the sum of \$359,232.75, with a reservation of minerals without the right of surface entry, and authorized the execution of a boundary line agreement in connection therewith. The description approved was by lot number, and a question exists as to whether a small street area in Santa Cruz Street was intended to be included. The title company has requested a clarification. The street is part of a proposed development, as shown on Exhibit "B". The State appraiser has advised that this street will not materially affect the appraised value, and that the sum of \$359,252.75 is adequate to cover all of the property described in said Minute Item 37, including the small street area that is described on the attached Exhibit A".
