15. 5-YEAR USE PERMIT, SUBMERGED LAND IN MONTEREY BAY OFFSHORE FROM SANTA CRUZ, SANTA CRUZ COUNTY, FOR MAINTENANCE OF 5 MARKER BUOYS; SANTA CRUZ YACHT CLUB, INC. - W.O. N-0398, P.R.C. 4174.1.

After consideration of Calendar Item 25 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:
