19. QUITCLAIMS, MINERAL EXTRACTION LEASES P.R.C. 210.1, P.R.C. 257.1, P.R.C. 2038.1, P.R.C. 3308.1, AND P.R.C. 3651.1, OWENS LAKE, INYO COUNTY; PITTSBURGH PLATE GLASS COMPANY - W.O. 7052.

After consideration of Calendar Item 6 attached, and upon motion duly made and carried, the following resolution was adopted:
