Those portions of the following-described piece or parcel of land lying within projected Sections 13, 23, 24 and the east half of Section 14, Township 3 North, Range 1 West, M.D.B.& M., and in the projected Sections 18, 19 and 20 in Township 3 North, Range 1 East, M D.B.& M., Solano County.

BEGINNING at the most southerly corner of the Chaplin Subdivision on Grizzly Island as shown on map filed August 25, 1911, Solano County records; thence along the westerly boundary of land of B. B. Co. South 22 degrees 2 minutes East 1198.6 feet, South 40 degrees 28 minutes East 2377.3 feet, South 35 degrees East 214.5 feet, South 31 degrees 37 minutes East 736.6 feet, South 32 degrees 35 minutes East 689.7 feet, South 34 degrees 45 minutes East 660 feet, South 40 degrees 0 minutes East 238.3 feet, South 49 degrees 30 minutes East 1260.6 feet to the most southerly corner of land of said B. B. Co.; thence South 45 degrees East 990 feet more or less to a point on a line between projected Sections 12 and 13, Township 3 North, Range 1 West, M.D.B.& M., said point being the true point of beginning; thence continuing South 45 degrees East to the north bank of the natural channel of Roaring River; thence following the bank of the natural channel of Roaring River westerly to the intersection of the N-S centerline of project Section 14, Township 3 North, Range 1 West, M.D.B.& M.; thence North 4900 feet more or less to the north line of said projected section; thence east along the north line of projected Sections 14 and 13, 7400 feet more or less to the true point of beginning, containing 1937 acres more or less.
