APPLICANT:

Department of Parks and Recreation, State of California.

LOCATION:

Ayala Cove, Angel Island, Marin County.

TYPE OF LANDS: State tide and submerged.

PURPOSE:

Development of a harbor for private and public watercraft.

AMOUNT TO BE DREDGED:

85,000 cubic yards.

DISPOSITION OF DREDGED MATERIAL:

To be spoiled in deep water east of Blunt Point, Angel Island.

CONSIDERATION: Public benefit.

OTHER PERTINENT INFORMATION:

- 1. A U. S. Army Corps of Engineers permit, valid through December 31, 1972, has been issued.
- 2. A San Francisco Bay Conservation and Development Commission permit had been issued through May 1, 1969; the applicant has requested an extension of the permit.
- 3. A letter of endorsement has been issued by the City of Tiburon.
- 4. The State Departments of Fish and Game and of Water Resources have issued unqualified approvals of the project.
- 5. The San Francisco Bay Regional Water Quality Control Board has approved the project subject to the following:
 - a. All dredging, stockpiling, construction, and operation of equipment for the work proposed should be performed so as to minimize roiling of Bay waters and to prevent timbers or floats that may be used in the work from drifting away as a threat to small craft.
 - If any dredged material is to be deposited as hydraulic fill, the applicant must file a report with the Board in accordance with the Board's Resolution No. 68-32.
