31. AWARD OF OIL AND GAS LEASE P.R.C. 4288.1, 236.5 ACRES STATE LAND AND RESERVED MINERAL INTEREST IN NORWALK AREA, LOS ANGELES COUNTY, TO AMERICAN PETROFINA EXPLORATION COMPANY - W-7159, P.R.C. 4288.1.

After consideration of Calendar Item 34 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION ACCEPTS THE BID MADE BY AMERICAN PETROFINA EXPLORATION COMPANY, AND AUTHORIZES THE ISSUANCE OF AN OIL AND GAS LEASE TO THE AFORESAID BIDDER FOR APPROXIMATELY 236.5 ACRES OF STATE LAND AND RESERVED MINERAL INTERESTS DESIGNATED AS W-7159 IN LOS ANGELES COUNTY, AS DETAILED IN THE NOTICE OF INTENTION PUBLISHED MAY 14 AND 21, 1969.
