After consideration of Calendar Item 39 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO THE DEPARTMENT OF PARKS AND RECREATION OF A 49-YEAR PUBLIC AGENCY PERMIT FOR A PUBLIC-USE RECREATIONAL PIER FROM MARCH 1, 1969, IN CONSIDERATION OF THE PUBLIC USE AND BENEFIT ON THE LAND DESCRIBED AS FOLLOWS:

ALL THAT PORTION OF THE FOLLOWING-DESCRIBED PARCEL LYING BELOW THE MEAN HIGH TIDE LINE OF THE PACIFIC OCEAN, BEING A STRIP OF TIDE AND SUBMERGED LAND IN THE PACIFIC OCEAN, 50 FEET IN WIDTH, LYING 25 FEET ON EACH SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:
