EXHIBIT "A"

That portion of a 3-foot strip of tide and submerged land in the Sacramento River, located in the City and County of Sacramento, State of California, lying l_2^1 ft. on each side of the following described center-line:

COMMENCING at a point at the intersection of the southerly right-of-way line of West Broadway and the westerly right-ofway line of the extension of West Broadway (said extension of West Broadway being that public street from the west end of West Broadway entering Miller Park, the centerline of which intersects the centerline of West Broadway approximately 100 feet east of the easterly bank of the Sacramento River); thence southerly along the westerly right-of-way line of said public street 6.00 feet to the TRUE POINT OF BEGINNING; thence westerly and parallel with the southerly right-of-way line of West Broadway, and the prolongation thereof, 100 feet; thence northerly 6.00 feet to the point of ending, being a point on the southerly right-of-way line, or the elongation thereof, of West Broadway.
