4. DREDGING PERMIT, T&S LANDS OF SAN FRANCISCO BAY AT SAN QUENTIN, MARIN COUNTY, FOR SEWAGE OUTFALL LINE; STATE OF CALIFORNIA, DEPARTMENT OF CORRECTIONS - W-7393, P.R.C. 4344.9.

After consideration of Calendar Item 35 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO THE STATE OF CALIFORNIA, DEPARTMENT OF CORRECTIONS, OF A PERMIT EFFECTIVE NOVEMBER 14, 1969, THROUGH DECEMBER 31, 1972, TO DREDGE 400 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM AN AREA OF TIDE AND SUBMERGED LAND IN SAN FRANCISCO BAY, MARIN COUNTY, AS DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF, WITH ALL DREDGED MATERIAL TO BE DISPOSED OF ON APPLICANT'S SAN QUENTIN PRISON PROPERTY.

APPLICATION FOR DREDGING PERMIT

APPLICANT: State of California, Department of Corrections.

LOCATION: San Quentin, San Francisco Bay, Marin County.

TYPE OF LAND: Tide and submerged, ungranted.

PURPOSE: Sewage outfall line.

AMOUNT TO BE DREDGED:
400 cubic yards.

DISPOSITION OF DREDGED MATERIAL:
To be disposed of on applicant's San Quentin Prison property.

CONSIDERATION: Public benefit.

OTHER PERTINENT INFORMATION:

1. A Department of the Army Letter of Permission has been issued, effective through December 31, 1972.
2. A San Francisco Bay Conservation and Development Commission permit has been issued, initially effective through December 31, 1969, then requiring six-month extensions.
3. The San Francisco Bay Regional Water Quality Control Board states that the proposed work is part of the Prison's commitment to them for sewage-treatment-plant upgrading which will permit compliance with requirements, and therefore urges approval of the application.

The Board further states that all dredging, stockpiling, construction, and the operation of equipment for the work described should be performed so as to minimize roiling of the waters, and to prevent timbers or floats that may be used in the work from drifting away as a threat to small craft.

4. The following State agencies have also approved the proposed work:
 - a. Department of Fish and Game.
 - b. Department of Water Resources.
5. The State Department of Parks and Recreation has examined and approved the proposed project, pursuant to Section 6818 of the Public Resources Code.

EXHIBIT "A"

That certain parcel of land situate in the Corte Madera Canal as said Canal is shown on Map No. 2 of Salt Marsh and Tide Lands, County of Marin, State of California, more particularly described as follows:

BEGINNING at a point on Course 71 (S. $67^{\circ} 44'$ E., 35.13 chains) which bears S. $67^{\circ} 44'$ E. a distance of 425 feet from the intersection of said Course 71 and Course 70 (S. $51^{\circ} 28'$ E., 27.86 chains), as these courses are shown on said Map No. 2; thence from said point of beginning South 140 feet; thence East 100 feet; thence North 99.05 feet to a point on said Course 71 and thence N. $67^{\circ} 44'$ W. 108.06 feet to the point of beginning.

Said parcel containing 0.274 acre more or less.
