3. DREDGING PERMIT, TIDE AND SUBMERGED LAND AT CONFLUENCE OF SAN JOAQUIN AND MOKELUMNE RIVERS, SACRAMENTO COUNTY; LLOYD KORTH - W-7370, P.R.C. 4375.9.

After consideration of Calendar Item 15 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES ISSUANCE TO LLOYD KORTH OF A PERMIT EFFECTIVE DECEMBER 18, 1969, THROUGH DECEMBER 18, 1971, TO DREDGE 9000 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM 4.21 ACRES OF STATE TIDE AND SUB-MERGED LAND LYING IN THE BED OF THE SAN JOAQUIN RIVER AND THE MOKELUMNE RIVER, SACRAMENTO COUNTY, AT THE POINT OF THEIR CONFLUENCE, AS DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF, WITH DREDGED MATERIAL BEING USED TO CONSTRUCT A BREAKWATER FOR THE MARINA EXTENSION.

DREDGING PERMIT

APPLICANT: Lloyd Korth.

LOCATION: At the confluence of the Mokelumne River and the San Joaquin River adjacent to Andrus Island, Sacramento County, in projected Section 20, T. 3 N., R. 4 E., M.D.B.& M.

TYPE OF LAND: Tide and submerged land.

FURPOSE: To build a new breakwater to protect the boats in the marina extension.

AMOUNT TO BE DREDGED:

9,000 cubic yards.

DISFOSITION OF DREDGED MATERIAL: Deposit on State land.

CONSIDERATION: Enhancement of State land value by virtue of improvements.

CTHER FERTILENT INFORMATION:

- 1. Applicant is proposing a lease extension of 4.21 acres of existing Lease P.R.C. 2215.1, upon which a new breakwater will be built.
- 2. A Department of the Army permit authorizing the project has been issued, effective through December 31, 1972.
- 3. The State Department of Parks and Recreation has examined and approved the proposed project, pursuant to Section 6818 of the Public Resources Code.

EXHIBIT "A"

A parcel of tide and submerged land in the State of California, County of Sacramento, and lying in the bed of the San Joaquin River and Mokelumne River at the point of their confluence, being more particularly described as follows:

COMMENCING at an iron pipe tagged L.S. 1818 on the northwesterly boundary of the A. C. Korth property; thence S. 07° 53' 00" E., 2,265.00 feet to the TRUE FOINT OF BEGINNING and bank of said rivers; thence S. 07° 53' %., 95.00 feet; S. 22° 08' E., 28.00 feet; S. 10° 32' W., 112.00 feet; S. 69° 17' W., 119.00 feet; thence leaving said parcel the following courses, N. 86° 41' 40" E., 136.83 feet; N. 88° 50' E., 142.00 feet; N. 58° 45' E., 146.00 feet; N. 44° 00' E., 110.00 feet; N. 41° 31' E., 420.00 feet; N. 79° 35' W., 314.00 feet; N. 76° 36' W., 75.47 feet to the bank of said rivers, thence southwesterly along said bank to the true point of beginning, containing 4.21 acres, more or less.

EXCEPTING therefrom any portion lying Landward of the ordinary high water mark.

The meridian of this description is identical with that for the description contained in the Amended Judgment, S.S.C. No. 81,526, in Sacramento, California.
