29. PERMIT TO PROSPECT FOR GEOTHERMAL RESOURCES, SUBMERGED LAND, MONO LAKE, MONO COUNTY; GEOTHERMAL RESOURCES INTERNATIONAL, INC. - W-6699, P.R.C. 4397.1.

APPLICANT: Geothermal Resources International, Inc.

LOCATION: Mono Lake, Mono County.

TYPE OF LAND: Submerged Land.

ACREAGE: 4,773.94.
