50. APPROVAL OF BOUNDARIES OF PROPOSED ANNEXATION OF TIDE AND SUBMERGED LANDS BY THE CITY OF EUREKA DESIGNATED AS GUNTHER ISLAND TIDELANDS ANNEXATION; HUMBOLDT COUNTY - W-2400.80.

After consideration of Calendar Item 11 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION APPROVES THE BOUNDARIES OF THE PROPOSED ANNEXATION BY THE CITY OF EUREKA DESIGNATED AS GUNTHER ISLAND TIDELANDS ANNEXATION, AS SHOWN ON EXHIBIT "A" ATTACHED AND INCLUDED HEREIN BY REFERENCE, AND AUTHORIZES THAT THE LOCAL AGENCY FORMATION COMMISSION OF THE COUNTY OF HUMBOLDT AND THE CITY COUNCIL OF THE CITY OF EUREKA BE INFORMED OF SUCH APPROVAL.

PROPOSED ANNEXATION OF TIDE AND SUBMERGED LANDS BY THE CITY OF EUREKA DESIGNATED AS GUNTHER ISLAND TIDELANDS ANNEXATION; HUMBOLDT COUNTY - W-2400.80.

The City of Eureka has asked the State Lands Commission to approve the boundaries of an annexation to the city designated as Gunther Island Tidelands Annexation, which includes tide and submerged lands owned by the State.

Section 35014 of the Government Code provides for approval or disapproval by the State Lands Commission of the boundaries of an annexation that includes State-owned tide and submerged lands. The State-owned tide and submerged lands included in the proposed annexation are a portion of Humboldt Bay. Staff review indicates that the boundaries of the proposed annexation meet the requirements of Government Code Section 35014. The approval of the boundaries is made pursuant to Section 35014 of the Government Code; it does not constitute approval by the State as owner of the tide and submerged lands lying within the proposed annexation, which will be a matter of separate future consideration by the Commission.

IT IS RECOMMENDED THAT THE COMMISSION APPROVE THE BOUNDARIES OF THE PROPOSED ANNEXATION BY THE CITY OF EUREKA DESIGNATED AS GUNTHER ISLAND TIDELANDS ANNEXATION, AS SHOWN ON EXHIBIT "A" ATTACHED AND INCLUDED HEREIN BY REFERENCE, AND AUTHORIZE THAT THE LOCAL AGENCY FORMATION COMMISSION OF THE COUNTY OF HUMBOLDT AND THE CITY COUNCIL OF THE CITY OF EUREKA BE INFORMED OF SUCH APPROVAL.

EXHIBIT "A"

DESCRIPTION OF PROPOSED GUNTHER ISLAND-TIDELANDS ANNEXATION

BEGINNING on the present City boundary at the most southerly corner of Tide Land Survey No. 121, also being the most easterly corner of Tide and Submerged Lands granted to the City of Eureka by the State of California under Chapter 187, Stats. of 1927, page 343;

thence northeasterly along a line parallel to the northerly right-of-way line of the California State Highway to its intersection with the Section line between Sections 3, 17, T5N, R1E;

thence westerly along the section line to the corner between Sections 7, 8, 17 and 18, T5N, R1E;

thence northwesterly to the center of Section 7, T5N, R1E;

thence westerly along the east-west 1/4 section line to the southwest corner of the southeast 1/4 of the northeast 1/4 section 10, T5N, R1W;

thence southwesterly to southwest corner of the southeast 1/4 Section 15, T5N, R1W;

thence southwesterly to the center of Section 21, T5N, R1W;

thence southwesterly to the corner between Sections 28, 29, 32 and 33;

thence southwesterly to a point 2,000 feet westerly along the east-west 1/4 Section line from the northeast corner southeast 1/4 Section 32, T5N, R1W;

thence easterly along the east-west 1/4 Section line to the existing City Limit line.
