FIFTH MODIFICATION OF THE 1969-70 PLAN OF DEVELOPMENT AND OFERATIONS AND BUDGET, LONG BEACH UNIT, JULY 1, 1969, THROUGH JUNE 30, 1970, WILMINGTON OIL FIELD, LOS ANGELES COUNTY.

The State Lands Commission, at its meeting of April 28, 1969, approved the 1969-1970 Plan of Development and Operations and Budget for the Long Beach Unit. Part IV of this Plan and Budget provides that necessary modifications of the Plan and Budget, together with revised exhibits, will be presented to the Commission at its regularly scheduled meetings in August and November 1969, and in February 1970.

Pursuant to this requirement, the City of Long Beach submitted the Fifth Modification of the 1969-1970 Plan and Budget, updating well locations on Exhibits A-2 throught A-6 and on B-2 through B-6. No additional funds are requested in this modification.

The staff has reviewed these modified exhibits and found them adequate, and recommends their approval.

Since the regular November 1969 meeting of the Commission was cancelled, the Executive Officer, by letter dated December 9, 1969, approved the Fifth Modification, pursuant to the provisions of Section 5(g), Ch. 138/64, lst E.S., subject to ratification by the Commission.
