RENEWAL OF LEASE P.R.C. 3342.1 A RIGHT-OF-ENTRY PERMIT

APPLICANT: Natomas Company.

LOCATION: A 0.069-acre strip of submerged land across American River approximately 650 feet downstream of Sunrise Boulevard Bridge, Sacramento County.

LAND USE: A bridge to facilitate hauling of gravel.

TERMS: Basic Lease: Two (2) years, from July 20, 1965, to July 19, 1967. Renewal Period: Eight (8) years, from July 20, 1967, to July 19, 1975.

CONSIDERATION: \$150 per annum, retroactive to beginning date of basic lease, July 20, 1965.

BASIS FOR CONSIDERATION:

\$150 minimum rental for this type of permit.

PREREQUISITE ITEM:

Applicant is owner of upland.

STATUTORY AND OTHER REFERENCES:

OTHER PERTINENT INFORMATION:

- 1. The basic lease provided for negotiation of a right-of-way with standard terms and conditions retroactive to the beginning date, July 20, 1965. This has not been possible, however, because of an uncertain boundary at the site.
- 2. Because of limited funds and personnel available to the Commission for land ownership determination work, it has not been possible to negotiate a boundary line of ownership and proceed with further negotiation of a right-of-way as provided for in the basic lease. Because of this, it appears to be in the State's best interest to renew and extend the right-of-entry permit and to set a rental without further delay.
