LOCATION:

A 2,835-square-foot parcel of submerged land in Lake Tahoe

near Homewood, Placer County.

LAND USE:

A pier with two covered boat berths and a sundeck.

TERMS:

5 years, from October 29, 1969.

CONSIDERATION:

\$75.00 per annum.

BASIS FOR CONSIDERATION:

\$75.00 fixed rental for this type of permit.

PREREQUI: . ITEMS:

U.S.A. Corps of Engineers Permit issued.

Applicants are owners of upland.

OTHER PERTINENT INFORMATION:

- (1) The pier, which is owned jointly by the applicants, is waterward of the boundary line separating applicants' individually owned upland lots.
- (2) The site was covered by a rent-free permit (P.R.C. 2486.9), which expired. A rental must be charged under current law because each lot is not improved with a single-family dwelling, now a requirement for rent-free status.
