7. AUTHORIZATION FOR ACCEPTANCE OF QUITCLAIM DEED, LEASE P.R.C. 3922.1, SUBMERGED LAND IN LAKE TAHOE, PLACER COUNTY; GEORGE J. SCHLENKER, CO-EXECUTOR OF THE ESTATE OF JOHN L. MERRILL, DECEASED - W-8663.

ACCEPTANCE OF QUITCLAIM DEED TO LEASE P.R.C. 3922.1

APPLICANT: George J. Schlenker, co-executor of the Estate of John L. Merrill, deceased.

LOCATION: A 30-x 168-foot parcel of submerged land in Lake Tahoe at Tahoe City, Placer County.

LAND USE UNDER EXISTING LEASE:

The proposed construction of an accommodation pier to serve occupants of a multi-family residential development, and the demolition of an old existing pier.

TERMS OF EXISTING LEASE: Initial period: 5 years, from February 29, 1968.  
Renewal options: 3 additional periods of 10 yrs. each.  
Surety bond: \$5,000.

CONSIDERATION OF EXISTING LEASE:  
\$150.00 per annum.

STATUTORY AND OTHER REFERENCES:

The existing lease would have expired February 28, 2003. The lessee has died and his duly appointed executor has executed a lease quitclaim deed. The existing structure has been removed.
