34. AUTHORIZATION TO ISSUE ONE-YEAR PUBLIC AGENCY RIGHT-OF-ENTRY PERMIT, SUBMERGED LAND IN THE SACRAMENTO RIVER, GLENN AND BUTTE COUNTIES; COUNTIES OF GLENN AND BUTTE - W-8445, P.R.C. 4445.9.

After consideration of Calendar Item 35 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO THE COUNTIES OF GLENN AND BUTTE OF A ONE-YEAR PUBLIC AGENCY RIGHT-OF-ENTRY PERMIT FROM APRIL 23, 1970, IN CONSIDERATION OF THE PUBLIC USE AND BENEFIT, FOR A BRIDGE RIGHT-OF-WAY ACROSS THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

PUBLIC AGENCY RIGHT OF ENTRY PERMIT

APPLICANT: Counties of Glenn and Butte.

LOCATION: A 1.6-acre strip of submerged land in Sacramento River near Ord Bend, Glenn and Butte Counties.

LAND USE: A temporary permit for construction of a fixed concrete bridge to replace an existing ferry operation.

TERMS: One year, from April 23, 1970.

CONSIDERATION: No charge pending agreement on reasonable value for right to cross submerged land.

PREREQUISITE ITEMS:
U. S. Coast Guard permit issued.
Applicants will purchase upland approaches.

STATUTORY AND OTHER REFERENCES:
a. Public Resources Code: Div. 6, Pt. 2, Ch. 1, Secs. 6501-6509.
b. Administrative Code: Title 2, Div. 3, Arts. 1 & 2 as amended effective May 10, 1969.

OTHER PERTINENT INFORMATION:
(1) The annual rental value of the site is estimated to be \$189.60.
(2) This non-monetary one-year permit will allow construction of the bridge to commence while terms and conditions of a standard Public Agency Permit are being worked out by the parties. The question of a reasonable value for the right to cross State submerged land will be resolved in conjunction with the State Division of Highways.

All that real property situate in the County of Butte and the County of Glenn, State of California, described as a strip of land 53 feet in width, the center line of which being described as the center line of the proposed new alignment of Ord Ferry Road.

To the extent that the same shall cross the submerged land of the State of California with the bed of the Sacramento River.
