A 10- x 608-foot (approximate) strip of tide and submerged land in the Sacramento River 0.5 miles above Isleton, Sacramento

County.

LAND USE:

The installation of a 20.8 KV submarine cable.

TERMS:

49 years, from May 1, 1970.

CONSIDERATION:

\$24.32 per annum during first five years, with the State reserving the right to review and reset a reasonable rental on each fifth anniversary.

BASIS FOR CONSIDERATION:

One cent par-diameter-inch-per-lineal-foot of conduit.
