28. AMENDMENT AND RENEWAL OF INDUSTRIAL LEASE PRC 618.1, FILLED TIDE AND SUBMERGED LAND IN CARQUINEZ STRAITS, CONTRA COSTA COUNTY; AMERICAN SMELTING AND REFINING COMPANY - W 8398.

During consideration of Calendar Item 26 attached, the Executive Officer read into the record a letter of November 16, 1970, from Mrs. Pat Barrentine, Executive Secretary of the Committee for Green Foothills, stating that it would seem that the Lands Commission should require that all other State agency requirements are met prior to the signing of a new lease. The Executive Officer reported that such compliance is required in all Commission leases and that Mrs. Barrentine would be so informed.

Upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO AMERICAN SMELTING AND REFINING COMPANY OF AN AMENDMENT TO AND THE SECOND TEN-YEAR RENEWAL OF LEASE NO. PRO 618.1 FROM OCTOBER 24, 1969, IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$20,000, PROVISION OF A \$75,000 SURETY BOND, AND PUBLIC LIABILITY INSURANCE IN AMOUNTS OF \$500,000/\$1,000,000 FOR PERSONAL INJURY AND \$100,000 FOR PROPERTY DAMAGE, FOR THE MAINTENANCE OF PORTIONS OF A SMELTING PLANT, SHIP MOORAGE AREA AND APPURTENANCES THERETO ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

OTHER PERTINENT INFORMATION:

This is the negotiated settlement achieved during the "Interim Extension" authorized at the April 1970 Commission meeting. The rental agreed upon in negotiations is recommended for approval for several reasons: The staff appraisal, less an estimated expense for obtaining Public Utilities Commission consent for a private railroad crossing, produced a rent of \$20,950. As consideration for accepting the Company's offer of \$20,000 annual rent, the State will receive intengibles of importance. Among them are: The right to impose an insurance

requirement on renewal; recognition of the right to describe and collect rent on a ship moorage area; recognition that the fill inures to the State upon expiration of the initial lease term; saving of litigation and survey costs; and recognition that the right to set "reasonable terms and conditions" is a unilateral right of the State.

### PARCEL ONE:

All that certain tide and submerged lands situate in the County of Contra Costa, State of California, as the same is more particularly described in that lease dated August 27, 1951, by and between THE STATE OF CALIFORNIA, Lessor, and AMERICAN SMELTING AND REFINING COMPANY, Lease PRC No. 618.1. Reference is hereby made to said lease description and the same is incorporated herein as though fully set forth.

### PARCEL TWO:
