## CALENDAR ITEM

FIFTH MODIFICATION OF THE 1970-1971 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGEF, LONG BEACH UNIT, JULY 1, 1970, THROUGH JUNE 30, 1971, WILMINGTON OIL FIELD, LOS ANGELES COUNTY.

The Commission, at its meeting of April 23, 1970, approved the 1970-1971 Plan of Development and Operations and Budget, Long Beach Unit. Part IV of this Plan provides for continuing review by the City and State of past and anticipated future operations. As a result of these reviews, Plan and Budget modifications are periodically recommended in order to conform with trends and developments. Section 5(g), Chapter 138/1964, 1st E.S., provides for Commission approval, or ratification of Executive Officer approval of all such modifications.

Pursuant to the above procedures, the Executive Officer, by letter dated December 23, 1970, approved the Fifth Modification of the 1970-1971 Plan and Budget, subject to ratification by the Commission.

The Fifth Modification adds three investment projects to the 1970-1971 Plan of Development. Funds are provided by budget transfer as necessary. The Budget total will remain unchanged. The three projects are:

- 1. Drill and equip two compaction monitoring wells, \$90,000.
- 2. Purchase five sets of skid-mounted production tanks, \$68,000.
- 3. Purchase six trailer-mounted blowout preventers, \$182,040.

The Division has reviewed the Fifth Modification, as submitted by the City of Long Beach, and finds the proposed projects desirable, and that the modification of the Plan of Development is reasonable.
