12. PROPOSED REDRICE OF WELLS "STATE 425" J-153 AND "STATE 392" J-61, HUNTINGTON BEACH FIELD, ORANGE COUNTY; SIGNAL OIL AND GAS COMPANY - E 392.1.

After consideration of Calendar Item 5 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE APPROVAL OF REDRILLING WELLS "STATE 425" J-153 AND "STATE 392" J-61 TO BE COMPLETED AS "STATE 392" S-153 AND "STATE 392" S-154, RESPECTIVELY, IN ACCORDANCE WITH THE PROPOSALS LUBMITTED BY SIGNAL OIL AND GAS COMPANY, THE TERMS AND CONDITIONS OF EXCHANGE OIL AND GAS LEASE 392.1, AND THE RULES AND REGULATIONS OF THE COMMISSION.

PERTINENT INFORMATION:

Signal has initiated a full-scale waterflood operation in the shallower Jones Zone and a pilot program in the deeper Main Zone. Considerable capital investment and additional operating costs have been required for the waterflooding operations, and production performance clearly indicates that the program has been successful, resulting in economic advantage to the State.

On December 17, 1970 (Minute Item 8, page 976), the Commission authorized the redrilling of two wells in the initial phase of extending the Main Zone Waterflood. Since that time the Commission has authorized the redrilling of four additional wells for the same purpose. The last of these wells is currently being redrilled.

In order to maintain a coordinated and uninterrupted secondary recovery development program, Signal has submitted an application to redrill two additional wells, "State 392" S-153 (formerly "State 425" J-153) to be redrilled into the Main Zone as a water injection well, and "State 392" S-154 (formerly "State 392" J-61) to be redrilled into the Main Zone as a producing well. The proposed completion intervals in these wells will provide the best spacing for optimum flood response. The surface locations of the wells are on the uplands.

The proposed redrilling programs and completion programs have been r viewed by the staff and determined to be in accordance with good engineering practices and the rules and regulations of the Commission. The Division of Oil and Gas has approved the redrilling of these wells.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE APPROVAL OF REDRILLING WELLS USTATE 425" J-153 AND "STATE 392" J-61 TO BE COMPLETED AS "STATE 392" S-153 AND "STATE 392" S-154, RESPECTIVELY, IN ACCORDANCE WITH THE PROPOSALS SUBMITTED BY SIGNAL OIL AND GAS COMPANY, THE TERMS AND CONDITIONS OF EXCHANGE OIL AND GAS LEASE 392.1, AND THE RULES AND REGULATIONS OF THE COMMISSION.
