SECOND MODIFICATION OF THE 1971-1972 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, JULY 1, 1971, THROUGH JUNE 30, 1972, WILMINGTON OIL FIELD, LOS ANGELES COUNTY.

The City of Long Beach has requested Commission approval of the Second Modification of the 1971-1972 Plan and Budget for the Long Beach Unit, in order to provide a more expedient approval procedure for changing the producing or injection interval of any well.

PART IV.B.5 of the 1971-1972 Plan and Budget required prior written agreement between the City Manager, City of Long Beach, and the Executive Officer, State Lands Commission, before commencing the redrilling, deepening, permanent plug back, permanent change of producing or injection interval, or permanent abandonment of any well.

This proposed Second Modification will provide for the delegation to the Department of Oil Properties, City of Long Beach, and to Long Beach Operations, State Lands Division, the joint approval for deepening, plug back, or permanent change in the producing or injection interval of any unit well in order to prevent a delay of relatively routine and frequent well-repair operations. Redrilling or the permanent abandonment of any well will continue to require the approval of the City Manager of the City of Long Beach and the Executive Officer of the State Lands Commission.

The Division has reviewed this modification, and finds that the proposed procedural changes are desirable and that the changes will avoid possible unnecessary delays in commencing normal well work on deepenings, permanent plug backs, and permanent changes in producing or injection well intervals.

IT IS RECOMMENDED THAT THE COMMISSION, PURSUANT TO SECTION 5(g), CHAPTER 138/1956, 1ST. E.S., APPROVE THE SECOND MODIFICATION OF THE 1971-1972 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, JULY 1, 1971, THROUGH JUNE 30, 1972.
