RATIFICATION OF THE SIXTH MODIFICATION OF THE 1971-1972 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY.

The City of Long Beach has requested approval of the Sixth Modification of the 1971-1972 Plan and Budget for the Long Beach Unit in order to provide for Long Beach Unit participation in the Petroleum Industry Coastal Emergency Cooperative.

This Cooperative was formed to provide mutual assistance and cooperation in the control of oil-spill emergencies that may occur along a portion of the southern California coast, which includes the Long Beach Unit. The Commission, at its meeting of October 7, 1971, approved the Agreement for Petroleum Industry Coastal Emergency Cooperative and found that entering into such agreement is in the public interest.

It is estimated that the Unit's share of the expense for this Cooperative will be \$16,000 for the first year, of which \$11,000 will be charged during the 1971-1972 Budget period. Since funds were not provided for this participation in the 1971-1972 Budget, it will be necessary to augment the Budget.

After this modification has been approved, the affected Budget categories will be as follows:

The above amounts have been adjusted to conform with the revision of the Fourth Modification as approved by the Commission at its meeting of October 28, 1971.
