DREDGE LOCATION: Granted Lands with minerals reserved to the State adjacent to docks at end of Mariposa Street, San Francisco.

PURPOSE: Maintenance of navigability in docking area.

DREDGE VOLUME: 90,000 cubic yards.

SPOILS LOCATION: Public dump area south of Alcatraz Island.

CONSIDERATION: Improvement of navigation.

## EXHIBIT "A"

A parcel of sovereign land lying in the City and County of San Francisco, State of California, more particularly described as follows:

> Commencing at the point of intersection of t e east line of Illinois Street with the former south line of 18th Street; thence east along said south line of 18th Street 930 feet; thence north 317 feet to the TRUE FOINT OF BEGINNING; thence worth 600 feet, thence east 1,050 feet, thence south 350 feet, thence west 150 feet, thence south 100 feet, thence west 425 feet, thence south 150 feet, thence west 475 feet to the true point of beginning, containing 12.1 acres more or less.

The basis of the bearings of this description is the former south line of 18th Street; this bearing is taken to be east.
