On October 6, 1970, the State Lands Commission was served in an eminent domain action brought by the City of Los Angeles against the Los Angeles and Salt Lake Railroad Company, et al. (Los Angeles Superior Court Case No. 986723). The property involved is located at Berths 206-209 in Los Angeles Harbor, and is being acquired for the Matson Container Terminal.

Staff investigation shows that there is no State Lands Commission property interest involved. Titles in the area were settled in Los Angeles Superior Court Case No. 86772, which determined that both Parcels 1 and 2 are located above the mean high tide line and both are located within the Rancho San Pedro.
